## Service Achievements – Disclosures June 2026

AccessNI processed 19,658 disclosure certificates. Information was disclosed on 736 certificates<sup>1</sup>.

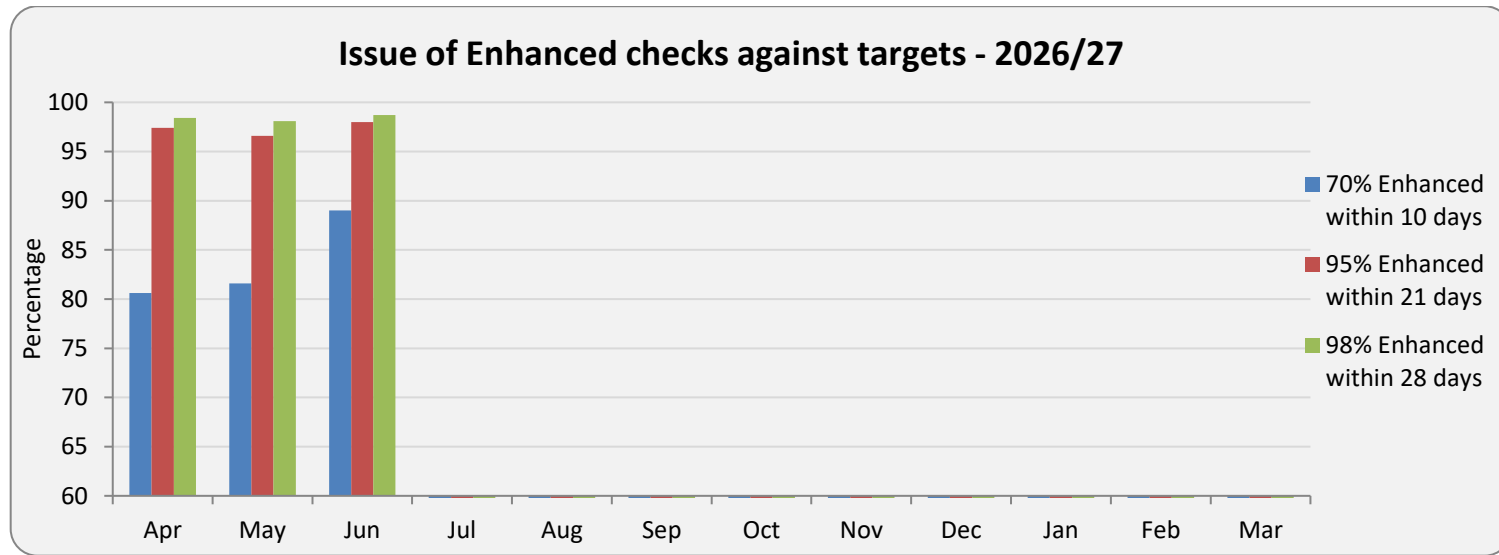
## **This month AccessNI also:-**

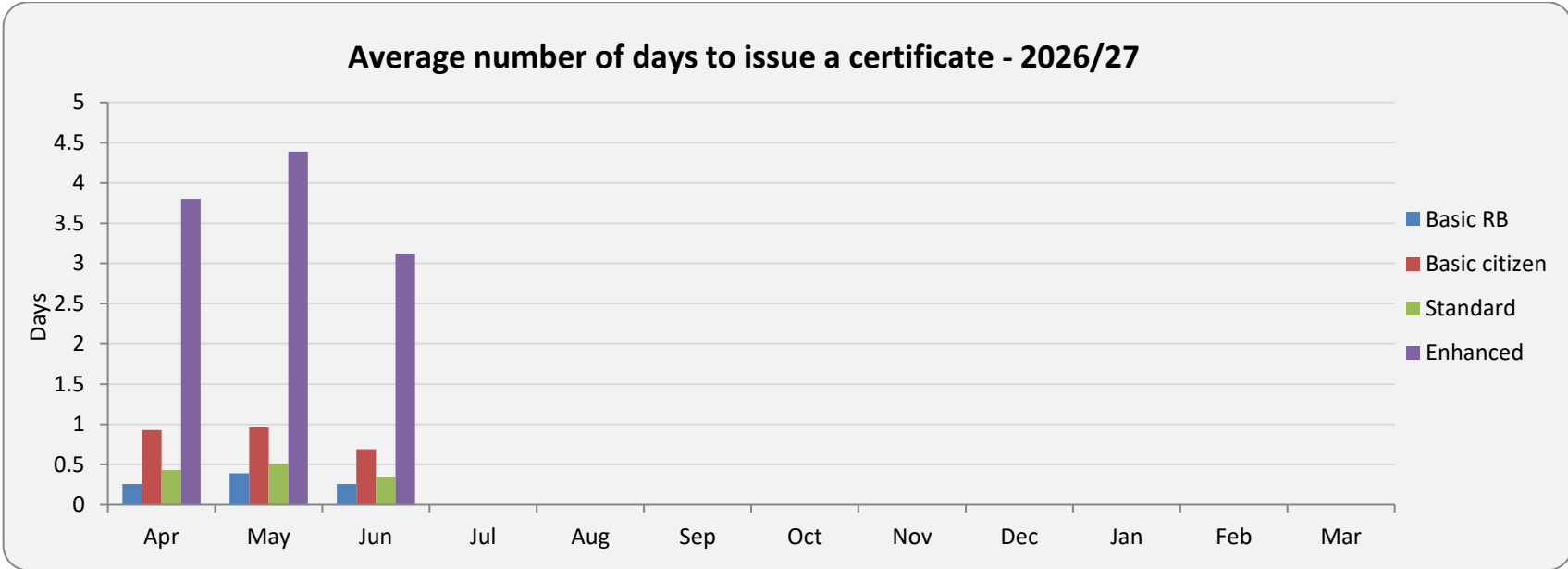
- Filtered 569 old and minor offences from Standard and Enhanced certificates;
- Made 64 auto-referrals of certificates with criminal record information to the Independent Reviewer;
- Referred 15 requests from applicants to have the criminal record information on their certificate reviewed by the Independent Reviewer;
- Made 166 referrals to the UK Central Authority for the exchange of criminal record information in respect of EU nationals seeking to work with children in Northern Ireland;
- There were no substantive disputes about criminal record information disclosed on certificates;
- Referred 3,097 applications for Enhanced certificates to PSNI and 677 to other police forces across the UK to find out if those forces had relevant information about the applicant that ought to be included on the disclosure certificate. PSNI made 6 disclosures of information and other police forces made 0 disclosure of information for inclusion in AccessNI certificates; and
- Made 14 compliance “visits” (via on-line technology) to Registered and Responsible Bodies.
