Thank you for your e-mail of 1 December 2014 which was treated as a request for information under the terms of the Freedom of Information Act 2000.

Please see your request and our response below:

I would like to submit a Freedom of Information request asking for a spreadsheet breakdown of the number of Lithuanian and Polish nationals in Northern Ireland's prisons over the last four years. Included in the breakdown I would like columns to outline the following where possible.

- **Gender;**
- **Age;**
- **Prison establishment;**
- **What the individual was convicted of;**

Please see attached tables. In view of the low numbers and in order to protect these individuals' identities the information has been provided in age groups. Please note that the same individuals may appear more than once over this timeframe.

The main offence groups have been listed. This information cannot be attached to the other tables as each inmate may have more than one 'main offence' recorded on the system. The resulting figures would be inaccurate and possibly misleading.

The information supplied to you continues to be protected by the Copyright, Designs and Patents Act 1988. You are free to use it for your own purposes, including any non-commercial research you are doing and for the purposes of news reporting. Any other re-use, for example commercial publication, would require the permission of the copyright holder.
