Thank you for your request which was treated as a request for information under the terms of the Freedom of Information Act 2000.

Please see your request and our response below:

Could you provide me with details of how much person injury compensation was paid out to prison officers and inmates in the last three financial years, broken down by prison, rank and date.

If possible, could you also provide details of the incident which compensated for.

Annex A contains the detail of amounts paid in compensation in the financial years, 13/14 (prisoners) and 14/15 (staff and prisoners) by specific categories of claim. These have been grouped together in order to protect the identity of individual claimants. To disclose further information would breach these individuals' rights under the terms of the Data Protection Act 1998 and the exemption at Section 40 of the Freedom of Information Act 2000 is thereby engaged. Publication of such personal information does not fulfil any of the necessary criteria for fair and lawful



processing and is therefore contrary to the First Principle of the Data Protection Act

1998. Annex B contains details of the public interest test conducted in this case.

The figures for 12/13 and the remainder for 13/14 (staff) are exempt from disclosure

under the terms of Section 1 of the Act by virtue of Section 21 of that Act which

states:

Information which is reasonably accessible to the applicant otherwise than under

Section 1 is exempt information. For the purposes of subsection (1)-

(a) information may be reasonably accessible to the applicant even though it is

accessible only on payment, and

(b) information is to be taken to be reasonably accessible to the applicant if it is

information which the public authority or any other person is obliged by or under any

enactment to communicate (otherwise than by making the information available for

inspection) to members of the public on request, whether free of charge or on

payment.

For the purposes of subsection (1), information which is held by a public authority

and does not fall within subsection (2)(b) is not to be regarded as reasonably

accessible to the applicant merely because the information is available from the

public authority itself on request, unless the information is made available in

accordance with the authority's publication scheme and any payment required is

specified in, or determined in accordance with, the scheme.
