Thank you for your letter of 28 January 2016 which was treated as a request for information under the terms of the Freedom of Information Act 2000.

## You requested:

Please provide the following information with regards to canine operational units.

1) How many GP dogs currently operational (broken down in to breeds).

2) How many Specialist Units (Explo, Narc, Cadaver, Firearms recovery, Containment, cash, other).

3) Breed selection and reasoning for role specific dog choice.

4) Cost of replacing an operational unit (GP and Specialist).

5) Other deployments for K-9 units that the force has trained operational teams (fire arms support etc.).

## Reply

1) There are 18 GP dogs. The breeds are Dutch Herder, Belgium Malinois and German Shepherd.



- 2) Specialist Units consist of Explosive Search dogs, Passive dogs and Active search dogs.
- 3) Any breed of dog may be used as selection depends on a dog's temperament and ability rather than breed.
- 4) There may be no cost or up to £2750 depending on the supply and demand issues at the time. We have dogs supplied from dog pounds and animal sanctuaries as well as breeders.
