**MC** advised members of the Department's consultation on the draft *Police Service* of Northern Ireland and Police Service of Northern Ireland Reserve (Injury Benefit) (Amendment) Regulations 2020 which issued to members on 2 October 2020, closes on 26th November 2020.

**AH** advised that the regulations will ensure that the injury benefit scheme continues to work effectively for officers who join the 2015 police pension scheme.

**LK** – Advised that he has sought and received comparable legislation and will be responding.
